### **Details of approval**

The syllabus was approved by The Board of the Department of Business Administration on 2019-05-16 and was last revised on 2021-11-01 by Academic Director of Studies at Department of Business Administration. The revised syllabus applies from 2021-11-01, spring semester 2022.

### **Learning outcomes**

A passing grade on the course will be awarded to students who:

#### **Knowledge and understanding**

Demonstrate knowledge and understanding of basic theories and research methods within international business.

#### **Competence and skills**

- Show ability to define and argue for a scientific topic based on previous academic
- research within international business.

- Show ability to identify, value and use established theories and methodologies in their own project.
- Show ability to communicate the research question and findings/result both orally and in writing.
- Can work both individually and as a member of a group in order to solve practical problems as well as manage an essay project within a certain time frame.
- Show such skill needed to participate in research and development programmes or other qualified business situations.

### **Judgement and approach**

- Demonstrate ability to judge the need of empirical material (the type and amount needed) and based on that can choose a suitable research method.
- Demonstrate an ability to make judgments within the chosen field, taking into account scientific, social and ethical aspects.
- Show understanding the role of knowledge in the society and awareness of human responsibility and how it is used.
- Show ability to identify personal need of further knowledge and competence development.

### **Course content**

The main objective is to develop students' ability to conduct an independent study that includes developing relevant research questions, and to design and conduct a study that addresses the research questions based upon appropriate methodological considerations and relevant theories within the field of International Business. The students should also be able to present their study in a written academic report, as well as orally. Students work independently and in smaller groups with designing and conducting their own study and on presenting their study in the form of a final written Bachelor's thesis. This includes to search and to select relevant literature on the appropriate theoretical area as well as on research methodology, and to collect relevant empirical data through e.g. field studies. Students are also expected to read and discuss the work of other students that attend the course.

### **Course design**

The teaching consists of lectures, seminars, assignments and tutor meetings. A seminar will be given by the end of the course when all students will have the opportunity to present and defend their essays and act as opponents of one or several essays.

### **Assessment**

The students will be assessed of their knowledge and skills achieved during the programme through the Learning Objective Assessment (LOA).

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

## **Entry requirements**

The students must be enrolled in the BSc in International Business programme (EGIBU) and have completed at least 90 credits (of which at least 30 credits should be within the subject International Business) in that programme.

## **Further information**

Discontinuation of the course: If the course is discontinued, students who have not yet passed the course will be offered three further examination opportunities on each of the assessed components within three semesters of the last semester the course was offered. Subsequently, it is only possible to receive certificates for passed components.
