# Learning outcomes

On completion of the course, the students shall be able to

## Knowledge and understanding

- provide a basic account of theories of feeling in Western thought and the links between ideas of feeling and conceptions of the body and soul
- outline the view of the role of feelings in communication in classical rhetoric

## Competence and skills

- critically examine classical Western texts about feelings
- analyse the use of emotional appeal in written media

## Judgement and approach

- reflect critically on historical and contemporary conceptions of feelings and their relation to the past and present view of mankind
- reflect on the interplay between ideas about feelings and social, political and cultural processes throughout history

#### Course content

The course provides students with an overview of prevailing theories of feeling within Western philosophy, rhetoric, medicine and psychology from Classical Antiquity to the 21st century. Theories of feelings are placed in relation to the categories of gender, class and ethnicity.

The use of emotional appeal in classical rhetoric is examined in concrete analysis assignments to highlight the way in which different cultures mobilise feelings for purposes of religion, politics, edification or social change? from seventeenth-century sermons to the suffrage movements of the twentieth century and the twenty-first century war on terrorism.

The course also provides an introduction to the historiographic discussion of feelings as an object for historical research.

# Course design

The teaching consists of lectures and seminars.

#### Assessment

The assessment is based on a final written assignment.
