# JAEN33, EU Competition Law, 15 credits EU Competition Law, 15 högskolepoäng Second Cycle / Avancerad nivå

## Details of approval

The syllabus is an old version, approved by Faculty of Law Board of education at undergraduate and postgraduate levels on 2010-12-07 and was last revised on 2014-12-11. The revised syllabus applied from 2015-01-19. , spring semester 2015.

## **General Information**

The course EU Competition Law is a compulsory course within the Master's Programme in European Business Law at the Faculty of Law. The course is open to students on the programme leading to a Swedish Professional Law degree, students following the Master's Programme in European Business Law, and to international students participating in exchange programmes with the Faculty of Law.

Language of instruction: English Teaching and course materials are in English. The course requires 10 weeks of full time studies.

## Learning outcomes

The aim of the course is to enable students to critically reflect upon the basic principles, legislation and case law of European Union Competition Law.

#### Knowledge and understanding

To pass the course the student shall:

• show a basic knowledge of the role of competition law in relation to the internal market

- show a basic understanding for the construction and application of Article 101(1) TFEU, which prohibits agreements, decision by associations of undertakings and concerted practices that are restrictive of competition
- show a basic understanding for the exemption criteria under Article 101(3)TFEU, the exemption procedure and the role and function of block exemptions
- show a basic understanding for Article 102 TFEU, prohibiting abuse of a dominant position
- show a basic understanding for the assessment of different types of anticompetitive conduct under Articles 101 and 102 TFEU
- show a basic understanding for the enforcement of Articles 101 and 102 TFEU in the courts of the Member States
- show a basic understanding for the role of national competition authorities in enforcing Articles 101 and 102 TFEU
- show a basic understanding for the regulation of mergers under the Merger Regulation.

#### Competence and skills

To pass the course the student shall:

- show the ability to master a wide range of diverse sources of legislation, case law and doctrine in European Union competition law
- show the ability to identify practical solutions in the application of competition law
- assess legal and economic issues in relation to competition law
- discuss competition law from a normative standpoint.

#### Judgement and approach

Students shall train inter-disciplinary working methods with colleagues from different cultural backgrounds and of the opposite gender. They shall simultaneously perform independent investigation and take full responsibility for the development of their own knowledge in an objective and critical manner.

## Course content

The course includes a review of the European Union competition law – its economic basis, legal substance and current legal developments. The course relies heavily on the study of the case law of the Union Courts and the Decisions of the EU Commission. In the appropriate contexts, such as mergers, joint ventures and licensing agreements, the particularities of high-technology markets, including the intersection with intellectual property law, will be highlighted. Moreover, part of the course is devoted to Competition law procedure. Here, focus is drawn upon the procedural rules and other formal aspects in proceedings before the EU Commission and the Courts. Also, the modernisation of the procedural rules in Regulation 1/2003 including the role of national competition authorities and the Merger Control Reform will be addressed.

## Course design

#### Assessment

Examination will take the form of a written exam. Grading will be based on oral and written presentations (50%) and the written exam (50%).

Subcourses that are part of this course can be found in an appendix at the end of this document.

## Grades

Marking scale: Fail, Pass, Pass with credit, Pass with distinction.

All grading criteria rest on the baseline set up for the grade B. Criteria for the grade BA are additional to those for the grade B. Criteria for the grade AB are additional to those for the grade BA. Each grading criterion consists of a qualitative and a quantitative dimension. To be awarded a specific grade, the grading criterion must be satisfied in its qualitative as well as its quantitative dimension.

Grading criteria are applied to the dimensions listed as "Learning outcomes" in this syllabus. By way of example, an AB would presuppose that the student's examination reflect her or his mastery with regard to knowledge and understanding, skills and abilities and values and attitudes as laid down in the syllabus as "learning outcomes". Grading is done primarily using Qualitative and Quantitative criteria. The Quantitative criterion reflects how well read the student is whereas the Qualitative criterion reflects how well read the student are use his/her knowledge to make a well structured critical and analytical argument and put it in a proper context.

#### **B** – Basic command

In order to achieve this grade the student must show good knowledge of diversity within competition law in both a theoretical and a practical perspective and demonstrate sound ability to critically evaluate the circumstances, workings and situations where this diversity plays a role[S1]. This includes sound knowledge of the European competition provisions, their application and scope. The student must demonstrate good knowledge of these instruments and of relevant secondary sources of law including Commission Decisions, the case law of the European courts and the evolving debate at EU level in relation to the enforcement of EU competition law provisions.

The student must demonstrate sound knowledge of the rules of interpretation, relevant to the rules[S2] of competition law and sound ability to apply these rules in an evaluation of a hypothetical factual scenario[S3].

The students must demonstrate good analytical and argumentation skills in both the oral and written form, as well as good ability to identify and apply the necessary exemptions relevant to EU competition law.

The student must demonstrate sound ability to understand the role of national authorities and national courts in applying the European Union competition rules.

#### **BA – Advanced command**

In order to achieve this grade the student must show very good knowledge of diversity competition law in both a theoretical and a practical perspective and

demonstrate sound ability to critically evaluate the circumstances, workings and situations where this diversity plays a role. This includes good knowledge of the European competition provisions, their application and scope. The student must demonstrate good knowledge of these instruments and of relevant secondary sources of law including Commission Decisions and the case law of the European courts and evolving debate at a EU level in relation to the enforcement of the rules.

The student must demonstrate very good knowledge of the rules of interpretation, relevant to the rules of competition law and sound ability to apply these rules in an evaluation of a hypothetical factual scenario.
