# JUDD36, Jewish Studies: Judaism and Gender, 7.5 credits Judaistik: Manlig och kvinnlig judendom, 7,5 högskolepoäng First Cycle / Grundnivå

## Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2015-12-01 and was last revised on 2018-10-24. The revised syllabus applies from 2018-10-24, spring semester 2019.

#### General Information

It is offered as a freestanding course. The course may be included in a first or second cycle degree.

## Learning outcomes

On completion of the course, students shall be able to

### Knowledge and understanding

- provide an account of the formulation of male and female gender roles within Judaism in different historical, ritualistic and religious contexts
- provide a comparative description of male and female gender roles within the different religious branches of Judaism

#### Competence and skills

• write an essay discussing the construction of female and male gender roles

### Judgement and approach

• based on issues of power, sex and ethnicity, take a position on how the view of masculinity and femininity has affected Jewish tradition and culture.

#### Course content

The course deals with the construction of male and female gender roles within Judaism during different historical periods and in different ritualistic and religious contexts, and to what extent religious ideas and myths impact on the Jewish conception of masculinity and femininity.

### Course design

The teaching consists of online lectures and webinars.

The course is offered entirely as a distance learning course and makes use of an online learning platform and/or digital tools. Students are required to participate under these conditions, and to have access to a computer with an Internet connection including a headset (microphone and headphones) and preferably a webcam. The department will provide information about the technical requirements.

#### Assessment

The course is assessed through five essays comprising 2-3 pages of text as well as two blog posts.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

#### Grades

Marking scale: Fail, Pass, Pass with distinction.

## Entry requirements

To be admitted to the course, students are required to have 30 credits within the humanities, social sciences or law.
