Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2018-06-13 to be valid from 2019-01-01, spring semester 2019.

General Information

Compulsory course in Bachelor's Programme in Church Music: first cycle 180 credits.

Language of instruction: Swedish

Main field of studies

Learning outcomes

The aim of the course is to enable students to acquire the following knowledge and skills on completion of the course.

Knowledge and understanding

The student shall on completion of the course

- show well developed knowledge of musical form and structure and also

- show well developed knowledge of harmonic and four part writing principles in music from different epochs.

Competence and skills

The student shall on completion of the course

- have the ability to critically reflect on the personal artistic approach in a wider artistic context and
- have the ability to formulate and independently study and carry out artistic assignments within the field of arranging and composition.

Judgement and approach

The student shall on completion of the course

- have the ability to discuss the own professional future and need for skill development and also
- have the ability to have a dialogue with other artists.

Course content

The course mainly consists of relevant literature chosen in consultation with the teacher in charge. The course assumes approved result of earlier course MUKY49.

Course design

The course is carried out in the form of individual lessons and group lessons, seminars and individual work (practicing, preparation).

Assessment

Examination of the course is arranged through continuous assessment and final tests. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Grades

Marking scale: Fail, Pass, Pass with distinction.

The course grade relates to the fulfillment of the learning outcomes of the course.

Fail means insufficient fulfillment of the course learning outcomes.

Pass means sufficient fulfillment of the course learning outcomes.

Pass with distinction means good and in-depth fulfillment of the course learning outcomes.

The course grading is done through the qualitative weighing of the fulfillment of the individual course learning outcomes.
