Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2018-06-13 and was last revised on 2020-09-22. The revised syllabus applies from 2020-09-22, autumn semester 2021.

General Information

Compulsory course in Bachelor's Programme in Music: Symphony Orchestra Instruments, Vocal Studies, Recorder, first cycle 180 credits.

Language of instruction: Swedish

Main field of studies

Learning outcomes

The aim of the course is to enable students to acquire the following knowledge and skills on completion of the course.

Knowledge and understanding

The student shall on completion of the course

- show craftsmanship at a basic level and
- when playing/singing show a basic understanding of the style and expression of the current repertoire.

Competence and skills

The student shall on completion of the course

- show the ability to study and carry out artistic assignments,
- show the ability to reflect on the personal artistic approach and
- show a basic ability for musical interplay in different constellations and ensembles.

Judgement and approach

The student shall on completion of the course

- show the ability to have a dialogue with other artists.

Course content

The course mainly consists of relevant literature for the specific instrument. In the courses Study and Interpretation 1- 6 the repertoire should comprehensively highlight the different epochs of music history including contemporary music. The course assumes approved result of earlier course MUSI70.

Course design

The course is carried out in the form of individual lessons, group lessons, seminars, guest lectures, workshops/master classes and individual work (practicing, preparations).

Assessment

Examination of the course is arranged through continuous assessment, concerts or tests. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Subcourses that are part of this course can be found in an appendix at the end of this document.

Grades

Marking scale: Fail, Pass, Pass with distinction.

The course grade relates to the fulfillment of the learning outcomes of the course.

Fail means insufficient fulfillment of the course learning outcomes.

Pass means sufficient fulfillment of the course learning outcomes.

Pass with distinction means good and in-depth fulfillment of the course learning outcomes.

The course grading is done through the qualitative weighing of the fulfillment of the individual course learning outcomes.
