# Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2017-11-29 to be valid from 2017-11-29, autumn semester 2017.

# **General Information**

Compulsory course in Master's Programme in Church Music: second cycle 120 credits.

Language of instruction: Swedish and English

Main field of studies

Music

Depth of study relative to the degree requirements AXX, Second cycle, in-depth level of the course cannot be classified

## Learning outcomes

To independently and on a high level be able to act in musical life, the student shall on completion of the course have acquired the knowledge, skills and values formulated below.

### Knowledge and understanding

The student shall on completion of the course

- have developed well profiled knowledge within the course's field of study,
- show considerably deepened knowledge and understanding of part of the course's field of study and also

• have deepened knowledge of artistic processes in general and own working methods in particular.

#### Competence and skills

The student shall on completion of the course

- show the ability to critically reflect on the personal artistic approach, and that of others, in a wider artistic context and also
- be able to independently identify, formulate and solve artistic problems and problems regarding interpretation.

#### Judgement and approach

The student shall on completion of the course

• show the ability to, within the main field of study, make assessments considering relevant artistic, social and ethical aspects.

#### Course content

Together with the faculty management the student makes an individual planning in which is placed strong emphasis on the student's needs and vision for musical development and direction. The course assumes approved result of earlier course MUSN52.

## Course design

The course can be carried out in the form of individual lessons, group lessons, seminars, workshops/master classes and individual work (practicing, preparations).

#### Assessment

Examination of the course is arranged through continuous assessment and tests/exams. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

### Grades

Marking scale: Fail, Pass.

## Entry requirements

In addition to general entry requirements for higher education at second cycle level the following specific entry requirements are applied:

Degree of Bachelor in Music 180 credits or the equivalent as well as passed selection based entrance examination for Master's Programme in Music.
