Learning outcomes

To independently and on a very high level be able to act in musical life the student shall on completion of the course have acquired the knowledge, skills and values formulated below.

Knowledge and understanding

The student shall on completion of the course

- show a particularly excellent craftsmanship,
- have developed a broadened knowledge within the main field of study,
- show particularly deepened knowledge and understanding of part or parts of the main field of study including insight in current research and development work, and

• have excellent knowledge of artistic processes in general and own working methods in particular.

Competence and skills

The student shall on completion of the course

- show a deepened ability to critically reflect on the personal artistic approach, and that of others, within a wider artistic context,
- show the ability to independently identify, formulate and solve artistic problems and problems regarding interpretation on a very advanced level,
- show the ability to create and realize own artistic ideas with a clear personal expression,
- show an ability for in-depth reflection on the own artistic approach and
- show the ability to plan the implementation of qualified artistic assignments within given time frames.

Judgement and approach

The student shall on completion of the course

- show a well developed ability to make assessments considering relevant artistic, social and ethical aspects.
- show a deepened ability to identify the personal need for further knowledge and to take responsibility for the personal knowledge development.

Course content

The course mainly consists of relevant literature for the specific instrument. In the courses Instrumental Studies 1- 4 the repertoire should comprehensively highlight the different epochs of music history including contemporary music. The course assumes approved result of earlier course MUSP14.

Course design

The course is carried out in the form of individual lessons, group lessons, seminars, guest lectures, workshops/master classes and individual work (practicing, preparations).

Assessment

Examination of the course is arranged through continuous assessment and tests, and through assessment at public concerts: within the courses Instrumental Studies 1-4 the student shall give a solo recital as well as a chamber music concert.

Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Grades

Marking scale: Fail, Pass, Pass with distinction.

The course grade relates to the fulfillment of the learning outcomes of the course.

Fail means insufficient fulfillment of the course learning outcomes.

Pass means sufficient fulfillment of the course learning outcomes.

Pass with distinction means good and in-depth fulfillment of the course learning outcomes.

The course grading is done through the qualitative weighing of the fulfillment of the individual course learning outcomes.

Entry requirements

In addition to general entry requirements for higher education at second cycle level the following specific entry requirements are applied:

Degree of Bachelor in Music 180 credits or the equivalent as well as passed selection based entrance examination for Master's Programme in Music.
