### Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2017-11-29 to be valid from 2017-11-29, autumn semester 2017.

### General Information

Compulsory course in Bachelor's Programme in Music: Symphony Orchestra Instrument, first cycle 180 credits.

*Language of instruction:* Swedish and English

*Main field of studies*

### Learning outcomes

The aim of the course is to enable students to acquire the following knowledge and skills on completion of the course.

#### Knowledge and understanding

The student shall on completion of the course

- show good direction towards a developed technical skill on the instrument and
- show good direction towards a developed understanding of the style and expression of the current repertoire.

### **Competence and skills**

The student shall on completion of the course

- show good direction towards the ability to independently study and carry out artistic assignments and also
- show good direction towards the ability to critically reflect on the personal artistic approach.

### **Judgement and approach**

The student shall on completion of the course

- show good direction towards the ability to have a constructive dialogue with other artists.

### **Course content**

The course mainly consists of relevant literature for the specific instrument. In the courses Instrumental Studies 1- 6 the repertoire should comprehensively highlight the different epochs of music history including contemporary music. The course assumes approved result of earlier course MUUD11.

### **Course design**

The course is carried out in the form of individual lessons, group lessons, seminars, guest lectures, workshops/master classes and individual work (practicing, preparations).

### **Assessment**

Examination of the course is arranged through continuous assessment, concerts or tests. Examination rules, such as e.g. examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.
