Details of approval

The syllabus is an old version, approved by The Board of the Department of Economics on 2015-05-05 and was last revised on 2015-05-05. The revised syllabus applied from 2015-05-05, spring semester 2016.

General Information

This is a single subject bachelor course in economics. The course can only be taken by students in Ekonomie Kandidatprogrammet.

Tuition is given in Swedish or English.

Main field of studies

Economics

Depth of study relative to the degree requirements

G2E, First cycle, has at least 60 credits in first-cycle course/s as entry requirements, contains degree project for BA/BSc

Learning outcomes

Knowledge and understanding

Students shall demonstrate:

- deepened knowledge within an economics specialisation of the student's choice including relevant theories and methods,
- an understanding of what theories and methods are relevant to analyse the chosen issue,
- knowledge of topical research within the chosen area.

Competence and skills

Students shall have the ability to independently:

- Identify and formulate a relevant issue and initiate and conduct a scientifically based analysis based on the chosen issue,
- Apply relevant theories and methods within the chosen area and draw well-founded conclusions,
- seek, collect, evaluate, analyse and critically interpret information,
- account for and discuss theories, methods, problems, solutions and results in a well structured and scientific manner, both orally and in writing,
- critically and constructively discuss phenomena and issues within the chosen area and other economic areas, integrate knowledge and abilities from
- different areas in the programme.

Judgement and approach

Students shall have the ability to independently:

- make judgements based on relevant scientific, social and ethical aspects,
- identify unanswered issues and new issues arising as a result of an analysis.

Course content

The course consists of writing an essay in economics that is publicly defended at a seminar with a discussant, being the main discussant of another essay at a seminar and actively participating in other seminars. In writing the essay, the student is advised by one or more tutors. The topic of the essay is determined by the issue chosen by the student after discussing with the tutor. The course starts with some gatherings for general information on writing essays and on information seeking.

The course also consists of a part where the student shall show specific knowledge from the various parts of the programme and an ability to integrate the various parts of the programme.

Course design

1. Teaching: In the beginning of the course, there are some information and teaching sessions. The course is ended by seminars. Apart from this, tuition consists of individual supervision.

At the start of an essay, the student states what seminar period the essay shall be presented. If an essay has not been presented at the latest two seminar periods after the stated seminar period, the student does not have the right to further supervision unless there are exceptional circumstances. If an essay has been presented but failed at two attempts, the student does not have the right to further supervision unless there are exceptional circumstances.

Assessment

1. Examination: Examination consists of a) writing the essay, b) presenting the essay at a seminar, c) acting as the main discussant of another essay and d) actively participating in at least three other seminars. Individual performance during the work on the essay can affect the grade. The grade is decided by an examiner and not the supervisor. The essay must be provided to the database of the Economic Library in order to pass the course.

2. Limitations on the number of examination opportunities: –

The University views plagiarism very seriously, and will take disciplinary action against students for any kind of attempted malpractice in connection with examinations and assessments. Plagiarism is considered to be a very serious academic offence. The penalty that may be imposed for this, and other unfair practices in examinations or assessments, includes suspension from the University for a specified period.

Grades

Marking scale: Fail, E, D, C, B, A.

1. Grading: Grade (Definition), Points or percentage out of maximum points, Characteristic

A (Excellent), 85–100, A distinguished result that is excellent with regard to theoretical depth, practical relevance, analytical ability and independent thought.

B (Very good), 75–84, A very good result with regard to theoretical depth, practical relevance, analytical ability and independent thought.

C (Good), 65–74, The result is of a good standard with regard to theoretical depth, practical relevance, analytical ability and independent thought.

D (Satisfactory), 55–64, The result is of a satisfactory standard with regard to theoretical depth, practical relevance, analytical ability and independent thought.

E (Sufficient), 50–54, The result satisfies the minimum requirements with regard to theoretical depth, practical relevance, analytical ability and independent thought, but not more.

U (Fail), 0–49, The result does not meet the minimum requirements with regard to theoretical depth, practical relevance, analytical ability and independent thought.

Students have to receive a grade of E or higher in order to pass a course.

Entry requirements

All the mandatory courses in Ekonomie Kandidatprogrammet and at least 60 ECTS-credits in economics, of which 30 ECTS-credits from the introductory course and the courses Intermediate Microeconomics (e.g. NEKG21) and Econometrics (e.g. NEKG31), or their equivalents are required for this course.

3. Limitations: This course may not be included in the same degree as NEK691 "Degree Project C", NEKK01 "Bachelor Essay" or NEKH01 "Bachelor Essay".

5. Limitations in renewed examination: When an essay is presented and get the grade Fail, the student may revise the essay. When the grade Fail is awarded, the examiner shall decide if the revision is of a nature that the essay will have to be presented at a new seminar or if it is sufficient to hand in the revised version. Essays that require a new seminar shall be handed in within a year. This means that the essay shall be handed in at the corresponding seminar period the year after at the latest. Essays that do not require a new seminar shall be handed in within six months after the grade Fail was awarded. Essays that receive the grade Fail for the second time shall be handed in in a revised version within three months after the grade Fail was awarded. For all later versions, the same rules apply as for essays that received the grade Fail for the second time.
