## Learning outcomes

On completion of the course the student shall

#### Knowledge and understanding

- be able to give a structured account of the consequences of migration in presentday Sweden on religious denominations and the relationship between religious denominations
- be able to fairly independently account for the impact of increased religious pluralism on Swedish society

#### Competence and skills

- be able to analyse the consequences of the changes in religious denominations due to migration on the basis of theories in religious studies and migration studies
- be able to analyse the societal changes caused by increased religious pluralism on the basis of theories in religious studies and migration studies

### Judgement and approach

- be able to analytically and critically problematise the concepts religion and migration
- be able to assess the changes in religious denominations due to migration from the perspectives of gender and power
- be able to critically assess the impact on society of increased religious pluralism from the perspectives of gender and power.

#### Course content

The course deals with the impact of migration on religion, focusing on present-day Sweden. A further area of enquiry is the position towards religious pluralism and the changes experienced as a result of religious pluralism in Swedish society. The changes are illustrated by empirical examples of Christian, Muslim, Buddhist, Hindu and Sikh communities in Sweden. Lectures, seminars and study visits highlight the complexity of the changes taking place. The changes are problematised from the perspectives of gender and power.

## Course design

The teaching consists of lectures, seminars and study visits.

#### Assessment

The assessment is based on a take-home exam at the end of the course.

#### Grades

Marking scale: Fail, E, D, C, B, A.

The highest grade is A and the lowest passing grade is E. The grade for a non-passing result is Fail.
