2. Conventions and other Legal Instruments

References will be made during lectures and in the prescribed reading material to various conventions, treaties, resolutions, declarations *etc.* Students should consult and study the *relevant parts* of the instrument referred to.

The instruments listed below constitute a central part of the course and students should familiarize themselves with each of these instruments *in its entirety*.

- *The Rome Statute establishing the International Criminal Court*, adopted in Rome on 17.7.1998 (available from the website of the ICC at www.icc-cpi.int), together with the *Elements of Crimes* and *Rules of Procedure and Evidence* (available under the 'Legal Tool' Section of the ICC website).
- *Statute of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (ICTY)*, updated version available from the ICTY website (www.un.org/icty)

- *Statute of the International Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens responsible for genocide and other such violations committed in the territory of neighbouring States, between 1 January 1994 and 31 December 1994 (ICTR)*, updated version available from the ICTR website (www.un.org/icttr)

- Judgment of the ICTY/R Appeals Chamber, 1.6.2001, *Akayesu*
