# COSM40, Asian Studies: Master's (Two Years) Thesis, 30 credits

## Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2019-10-29 and was last revised on 2022-09-15. The revised syllabus applies from 2022-09-15, spring semester 2023.

#### General Information

The course is mandatory in the fourth semester of the Master of Science Programme (120 credits) in Asian Studies.

# Learning outcomes

On completion of the course, the student shall:

### Knowledge and understanding

- be able to discuss general research questions in the field of contemporary Asian studies and demonstrate more in-depth knowledge about current research questions within one specific research area.
- be able to identify existing knowledge and describe it in a way that show deeper cultural understanding.
- be able to choose relevant theories, collect adequate materials and choose methods relevant for the task

#### Competence and skills

- be able to independently, critically and creatively identify and formulate problems of relevance to Asian studies.
- be able to critically and systematically discuss and integrate both secondary and primary data and analyse, asses, and deal with complex phenomena, questions and intercultural situations.
- be able to describe, use, and problematize different methods for data collection and analysis as well as discuss the relevance of these in order to solve a specific research task.
- be able to describe, use, and problematize different theories and perspectives as well as discuss the relevance of these in order to solve a specific research task.
- be able to independently analyze a research work as well as interpret and analyze the data in order to make well considered conclusions.
- be able to defend the master thesis at a seminar and oppose other theses at the master level.
- be able to correctly cite and refer to the literature and other relevant sources.

#### Judgement and approach

- be able to apply a critical, theoretically informed and disciplinary-based approach to the interdisciplinary field of Asian studies.
- be able to make ethical judgements and discuss the responsibility of the researcher in relation to Asian studies.
- be able to evaluate the possibilities and limitations of research, its role in society and the responsibility of the individual for how it is used.
- be able to identify the personal need for further knowledge and take responsibility for future knowledge development.

#### Course content

The Master's thesis is the culmination of the student's work during the programme and should address social, cultural, political and/or economic issues in contemporary Asia. The work consists mainly of the student completing a study and collecting material, possibly in the region, and writing an independent thesis of 30 högskolepoäng. The work is guided by a supervisor who provides constructive feedback on the basic structure of the study and during the course of the work. The length of the thesis should be approximately 15,000 words and have to be defended at a seminar.

# Course design

Teaching consists of supervision and seminars. Supervision is normally limited to the semester in which the student was first registered for the course. However, exceptions can be made if there are special reasons.

#### Assessment

The course is examined through the student's defence at a seminar of his or her thesis. The defense of one's own thesis and the student's critical review of another

thesis is mandatory.

Written instructions for opponents and respondents are given well in advance of the seminar.

An additional seminar is offered the following semester.

Passed degree projects at the Joint Faculties of Humanities and Theology can be registered in the LUP Student Papers database if the student so wishes.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

#### Grades

Marking scale: Fail, E, D, C, B, A.

The grades awarded are A, B, C, D, E or Fail. The highest grade is A and the lowest passing grade is E. The grade for a non-passing result is Fail.

At the start of the course students are informed about the learning outcomes stated in the syllabus and about the grading scale and how it is applied in the course.

## Entry requirements

Admitted to the Master of Science Programme in Asian Studies. In order to be eligible for the course, students must have completed at least 75 credits of coursework within the programme, including the course COSM22 Methodology in Theory and Practice (15 credits) or CÖSM22 Methodology in Theory and Practice (15 credits) or ACER22 Methodology in Theory and Practice (15 credits).

Oral and written language proficiency in English equivalent to English 6/B from Swedish upper secondary school is a requirement. International qualifications will be assessed in accordance with national guidelines.

A general exemption from the requirement of proficiency in Swedish is applied.

- 1. The course is given at the Department of History, Centre for East and South East Asia Studies.
- 2. The course replaces CÖSM40: Asian Studies: Master's (Two Years) Thesis (30 credits).
- 3. The credits allocated for course content that in whole or in part is commensurate with another course can only be credited once for a degree.
