### **Details of approval**

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2023-06-14 to be valid from 2023-09-01, spring semester 2024.

The course is offered as a freestanding course. It can normally be included in a general qualification for both first and second-cycle studies.

### **Learning outcomes**

On completion of the course, the students shall be able to:

#### **Knowledge and understanding**

- be able to give a structured account of the complexity in and the discussions of the concepts anti-semitism and islamophobia,
- compare and contrast the concepts of anti-semitism and islamophobia,
- give an account of the historical and ideological roots of the anti-semitism and islamophobia,
- give an account of how the concepts of anti-semitism and islamophobia have been used in the past and in the present day,

## Competence and skills

- critically discuss how the concepts of anti-semitism and islamophobia are used in studies of religion, orally and in writing,
- critically discuss how anti-semitism and islamophobia are used in processes of religious, cultural and political "alienation",
- discuss how anti-semitic and islamophobic ideas come to expression in different conspiracy theories,
- Orally and in writing, be able to analyse and discuss anti-semitic and islamophobic language and actions in the past and in the present day,

## Judgement and approach

- using a critical and research-based approach, be able to reflect on the complexity in the scientific study of the concepts anti-semitism and islamophobia,
- critically evaluate accusations about anti-semitism or islamophobia directed towards individuals, states and departments considering the history and geopolitical circumstances in which accusations of these concepts are expressed,
- evaluate the use of and disputes around the concepts anti-semitism and islamophobia in broader debates and how social enemies are designed and minorities are alienated.

## Course content

The course is based on a religious studies perspective to discuss the concepts anti-semitism and islamophobia concept that refers to fears and prejudices vis-à-vis Jews, Judaism, Muslims and Islam. By focusing on the historical, theological/the ideological, political and cultural aspects of anti-semitism and islamophobia, the historical roots and the contemporary forms of these fears and prejudices are explored. The course starts by problematising the concepts anti-semitism and islamophobia and continues by analysing how these concepts have been used in order to designate "the enemy" and in processes of religious, cultural and political "alienation". Thereafter, the historical roots and ideological contexts in which anti-semitism and the islamophobia arise and develop are studied. The course concludes by focusing on modern and contemporary manifestations of anti-semitism and islamophobia, such as, for example, how conspiracy theories are used in order to heighten hostility towards Jews and Muslims today. In the course, the opportunity to explore the complexity of anti-semitism and islamophobia as concepts and phenomena is offered through a study trip to Israel and Palestine.

## Course design

The teaching consists of lectures, 3-4 seminars and a week-long study trip to Israel/Palestine. All seminars are compulsory. The study trip to Israel/Palestine are optional and the number of places on the travel is reduced. The students who register early for the course be given precedence. Application for the study trip is binding. There is a cost associated with the study trip. The students pay for their travel, while the department covers all other expenses apart from meals in connection with field trips. Students can make up for missed seminars through written assignments in accordance with the lecturer's instructions.

## Assessment

The course is examined through oral examination at three seminars and a written assignment at the end of the course.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

## **Grades**

Marking scale: Fail, Pass, Pass with distinction.

The grades awarded for the seminars are Pass or Fail. For the grade of Pass on the whole course, a Pass grade on all seminars and the grade Pass on the written examination is required. To pass the course with distinction, a Pass grade on all seminars and the grade Pass with distinction on the written examination is required.

## **Entry requirements**

Entry to the course requires that the applicant have at least 60 credits or equivalent.
