### Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2017-04-21 to be valid from 2017-04-21, autumn semester 2017.

### General Information

The course is included in the Bachelor of Arts programme in European Studies with a humanities profile. The course can normally be included in a first or second cycle degree.

### Learning outcomes

On completion of the course, the students shall be able to

#### Knowledge and understanding

- provide a general account of important historical events and the main features of the societal development in the Mediterranean countries of Greece, Italy, Spain and France, from the early Middle Ages to the present day
- reflect on continuity and change in the cultural-historical development in the Mediterranean countries

### **Competence and skills**

- provide a general description and discussion in speech and writing of the historical development in the region from a European historical perspective
- seek, collect, evaluate and critically analyse information about the historical, cultural and societal development of the Mediterranean countries
- compose a brief written assignment that comparatively addresses a delimited cultural, political or other societal issue of relevance to the countries in the region

### **Judgement and approach**

- discuss issues regarding the integration of the region in international structures (mainly the EU) from different perspectives
- independently assess and critically reflect on social, cultural and political processes in the Mediterranean countries

### **Course content**

The course provides students with perspectives on the Mediterranean countries of Greece, Italy, Spain and France as a region in Europe. It also provides an overview of the four countries' historical development, from the Middle Ages to the present day, focusing on culture and societal development.

### **Course design**

The teaching consists of lectures and seminars. The course includes 1?3 compulsory seminars.

### **Assessment**

The assessment is based on a written invigilated exam and on active participation in compulsory seminars.

*The examiner, in consultation with the Disability Support Service, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.*

## Grades

Marking scale: Fail, Pass, Pass with distinction.
