Details of approval

General Information

The course is included in the Bachelor of Arts programme in European Studies with a humanities profile. It can normally be included in a first or second cycle degree.

Learning outcomes

On completion of the course, the students shall be able to

Knowledge and understanding

- provide a general account of important historical events and the main features of the societal development in Northern Europe, Germany and Great Britain, from the early Middle Ages to the present day
- provide examples of continuity and change in the cultural-historical development in Northern Europe, Germany and Great Britain

Competence and skills

- provide a description and discussion in speech and writing of the historical development in the region from a European historical perspective
- seek, collect, assess and critically analyse information about the historical, cultural and societal development of Northern Europe, Germany and Great Britain
- compose a brief written assignment that comparatively addresses a delimited cultural, political or other societal issue of relevance to the countries covered by the course

Judgement and approach

- discuss issues regarding the integration of the region in international structures (mainly the EU) from different perspectives
- independently assess and critically reflect on social, cultural and political processes in Northern Europe, Germany and Great Britain

Course content

The course provides students with perspectives on Northern Europe, Germany and Great Britain as special regions in Europe. Furthermore, it provides an overview of the historical development in Northern Europe, Germany and Great Britain, from the Middle Ages to the present, focusing on culture, societal development and religion. The course also includes a discussion of the heritage of the Holy Roman Empire, the Hanseatic League, the Swedish Great Power Era and of England's period as a colonial power.

Course design

The teaching consists of lectures, film screenings and seminars. The course includes 173 compulsory seminars.

Assessment

The assessment is based on a written invigilated exam and on active participation in compulsory seminars.

The examiner, in consultation with the Disability Support Service, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Grades

Marking scale: Fail, Pass, Pass with distinction.

Entry requirements

To be admitted to the course, students must have passed EUHA10 and EUHA12 or the equivalent.
