# **General Information**

Subject: The History of Ideas

The course is offered as a single course. It can normally be included as part of a general degree at the undergraduate or graduate levels. With the approval of the relevant authenticating body, it can also be included in certain professional degrees.

Language of instruction: Swedish

Main field of studies

History of Ideas and Sciences

Depth of study relative to the degree requirements G1N, First cycle, has only upper-secondary level entry requirements

## Learning outcomes

On completion of the course the student shall

#### Knowledge and understanding

- be able to give an account of how the ideological and cultural debate regarding religion and science has developed throughout history
- be able to discern the political, ideological and cultural consequences of the debate regarding science and religion historically and in the present.

#### Competence and skills

- be able to discuss the importance of the debate on science and religion today, both in Sweden and internationally
- be able to formulate and delimit a research issue through the production of an assessed written assignment.

#### Judgement and approach

• be able to evaluate the main features of the ideological, political and cultural importance of the debate on science and religion today.

#### Course content

The course deals with the various religious and scientific understandings of the world, their similarities and their differences. It discusses how both these understandings have developed throughout history and how they have competed with and been confronted by each other. Emphasis is on the present situation, and how religious understanding of the world has taken on a new shape in the form of the movement for "intelligent design" and is challenging science from new angles.

# Course design

Teaching consists of lectures and seminars.

#### Assessment

Examinations take the form of an assessed written assignment.
