Details of approval

The syllabus was approved by Faculty of Law Board of education at undergraduate and postgraduate levels on 2008-12-09 to be valid from 2008-12-09, spring semester 2009.

General Information

The course Master Thesis is a compulsory course within the Master's Programme in International Human Rights Law within the specialization in International Human Rights Law and Intellectual Property Rights.

The course is scheduled to require 20 weeks of full time studies in Lund.

Language of instruction: English

Lectures and course material are in English.

Main field of studies

Human Rights

Depth of study relative to the degree requirements

A2E, Second cycle, contains degree project for Master of Arts/Master of Science (120 credits)

Learning outcomes

The purpose of the course is to give the student an in-depth insight in a selected topic of international human rights law and particularly on intellectual property rights. This is facilitated through writing a qualified essay on Master level. Furthermore, the purpose is to enhance the ability of the student to conduct research and to practice the analytical skills and advanced argumentation and legal method that are required in an international and national legal profession.

Knowledge and understanding

To pass examination the student shall show:

- in-depth knowledge concerning the selected topic within international human rights law and intellectual property rights, and about the vector where these two set of rights meet
- in-depth knowledge of the scientific and methodological foundations of this branch of law
- knowledge about current international human rights and intellectual property rights research and methodology.

Competence and skills

To pass examination the student shall show:

- ability, on an advanced level, to critically and systematically assess and integrate knowledge in intellectual property rights and international law and human rights standards
- ability to independently, critically and creatively identify legal problems and to systematize arguments, and to analyze, compare and assess theoretical and practical problems within the context of intellectual property rights and international law and human rights standards
- ability to plan and pursue qualified tasks within given time frames and to contribute to the development of knowledge and to assess the performance.

Judgement and approach

To pass examination the student shall show

- ability to make an assessment regarding societal aspects of intellectual property rights and international law and human rights standards
- insight regarding the role international property rights plays in the interaction between states and individuals/groups and in the international community as a whole
- insight regarding the role of international and regional organizations in the international property rights law making processes
- ability to realize the advantages and disadvantages of international property rights and its impact on the state organization and legislation
- ability to continuously develop the knowledge about international property rights and its underlying theories and methods.

Course content

Instruction is given in the forms of mandatory seminars.

Course design

A supervisor is assigned for every student. The student has a right to individual supervision during the term she or he is initially registered for the Master thesis course. In cases of re-registration, a supervisor is assigned only if there are special circumstances or if the supervisor has approved the extension.

Assessment

Examination is in the form of seminars and the writing of a Master thesis. In order to fulfil the course the student is also required to have participated in ten final thesis defence seminars of other students.

The student must participate in all the mandatory seminars during the course. The Master thesis is defended at a public thesis defence seminar where the thesis is presented and defended. Each student must be an opponent at another thesis defence seminar. The thesis defence seminar and the opposition are compulsory elements of the examination.

The thesis shall be handed in for publication in an electronic form when finished and after the final examination.

Grades

Marking scale: Fail, Pass, Pass with credit, Pass with distinction.

Entry requirements

Passed examination on 90 credits from the three first terms of the programme.
