Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2015-11-27 to be valid from 2016-01-18, spring semester 2016.

General Information

The course is offered as a freestanding course. It can be included in a first or second cycle degree.

Language of instruction: Swedish

Learning outcomes

On completion of the course, the students shall be able to

Knowledge and understanding

- account for central personalities, events and phases in Jewish history based on the required reading
- account for political, cultural, economic and social circumstances and changes that have characterised Jewish history, Jewish culture and Jewish religion

Competence and skills

- with a certain degree of independence use the concepts "imagined community", "collective memory" and "cultural memory" to discuss in writing issues of the relationship between the use of history and identity formation

Judgement and approach

- take a position on and judge how women and men throughout history have put their stamp on Jewish tradition and culture in relation to prevailing social structures

Course content

The course deals with Jewish history and Jewish culture from a mainly chronological perspective. Key historical events and personalities are highlighted from a Jewish perspective. The course also addresses Jewish history, memory and identity from a clear outside perspective. This perspective is based on issues of, for example, the relationship between history and identity, facts and collective memory, historical interpretation and the presence of parallel historiography.

Course design

The teaching consists of lectures and seminars.

The course is a distance learning course supported by an online learning platform and digital tools. It presupposes that students who enrol on the course understand these conditions and have access to a computer with internet connections and a headset (microphone and headphones) and preferably web camera. The department provides information about the technical requirements.

Assessment

The assessment of the course is based partly on minor online repetition exercises during the course, partly on a final written exam in which students are permitted to use the required reading and their own notes.

Grades

Marking scale: Fail, Pass, Pass with distinction.

Entry requirements

General requirements and studies equivalent of the courses History 1b or 1a1+1a2 and Social Studies 1b or 1a1+1a2 from Swedish Upper Secondary School.
