Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2015-11-27 to be valid from 2016-01-18, spring semester 2016.

General Information

The course is offered as a freestanding course. It can be included in a first or second cycle degree.

Learning outcomes

On completion of the course, students shall be able to

Knowledge and understanding

- account for the stereotypes of Jewish humour
- exemplify how Jews have used humour to represent and relate to Jewish identity, religion, culture and history, and their relationship to Gentile society

Competence and skills

- individually and in groups perform a contextual reading of Jewish humorous texts
- independently execute a basic textual analysis
- orally present a given material

Judgement and approach

assess the role of humour for the identity of a community

Course content

The course enables the students to specialise and broaden their knowledge of Jewish religion and identity, history and tradition from the 19th century to the present using the required reading, Jewish humorous anecdotes and short stories. The emphasis is placed on a western context, highlighting above all the relationship between social context, Jewish identity and Jewish humour, as well as the contribution of humour to the creation and maintenance of a Jewish identity. The course deals with classical Yiddish humour and its characters, humour in the context of persecution and present-day Jewish humour, and addresses the question whether present-day Jewish humour is specifically Jewish or an element permeating western culture as a whole.

Course design

The teaching consists of online lectures and webinars.

The course is a distance learning course supported by an online learning platform and digital tools. It presupposes that students who enrol on the course understand these conditions and have access to a computer with internet connections and a headset (microphone and headphones) and preferably web camera. The department provides information about the technical requirements.

Assessment

The assessment is continuous and based on five written assignments and a final individual home assignment amounting to approximately 5-8 pages.

Grades

Marking scale: Fail, Pass, Pass with distinction.

Entry requirements

General requirements and studies equivalent of the courses History 1b or 1a1+1a2 and Social Studies 1b or 1a1+1a2 from Swedish Upper Secondary School.
