## LIVB10, Comparative Literature: Level 1, 30 credits Litteraturvetenskap: Grundkurs, 30 högskolepoäng First Cycle / Grundnivå

## Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2023-03-07 to be valid from 2023-03-15, autumn semester 2023.

#### General Information

The course is offered in the Bachelor's programme in Comparative Literature. It can be included in a first or second-cycle qualification.

## Learning outcomes

On completion of the course, the students shall be able to:

### Knowledge and understanding

- give an account of key developments and works in Western literature from Classical Antiquity up to and including Romanticism
- communicate a basic understanding of older literature from non-European language areas
- on a general level, describe the historically important concepts of poetry up to and including Romanticism
- describe and illustrate the linguistic and distribution-related conditions for literature in different periods
- describe and illustrate the economic, political and ideological conditions for literature throughout history

#### Competence and skills

- analyse and interpret literary texts and their functions in the shifting historical contexts relating to aesthetics, genre, society, gender and ideology.
- apply basic terms and concepts from literary studies in relation to different types of literary texts
- discuss, write about and make oral presentations on literature in different contexts

#### Judgement and approach

- relate the values of literature and literary studies to general societal and scholarly approaches
- judge and evaluate interpretations of different literary works
- identify their own need for further knowledge and expertise.

#### Course content

The course provides basic skills to analyse, interpret and discuss literary texts and the ability, in line with shifting practical applications, to communicate knowledge and experiences about literature. The course also provides basic knowledge of the history of literature from Classical Antiquity up to and including Romanticism — about how the societal and cultural function of literature has shifted throughout history and how the conditions to write, publish, distribute, understand and discuss literature have changed between different eras and literary cultures. The emphasis of the course in on the history of Western literature, but certain perspectives are included on the history of literature in other parts of the world.

The course consists of the following modules:

- 1. Fundamentals of Literary Studies: The Analysis of Narrative, Poetry and Drama, 7.5 credits
- 2. Survey of Literary History: From Antiquity to the Renaissance, 7.5 credits
- 3. Survey of Literary History: From the Seventeenth Century to Romanticism, 7.5 credits
- 4. Fundamentals of Literary Studies: The Author, the Public Sphere and Society, 7.5 credits

# Course design

The teaching consists of lectures, exercises, discussion seminars and supervision.

Compulsory components occur in the following modules:

Module 1, 3 seminars

Module 4, 1 seminar

In the case of non-attendance, a supplementary assignment according to the lecturer's instructions is required.

#### Assessment

1. The Analysis of Narrative, Poetry and Drama, 7.5 credits, is examined through a take-home exam.

- 2. From Antiquity to the Renaissance, 7.5 credits, is examined through an invigilated exam.
- 3. From the Seventeenth Century to Romanticism, 7.5 credits, is examined through an invigilated exam.
- 4. The Author, the Public Sphere and Society, 7.5 credits, is examined through a takehome exam.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Subcourses that are part of this course can be found in an appendix at the end of this document.

#### Grades

Marking scale: Fail, Pass, Pass with distinction.

For the grade of Pass on the whole course, the student must have been awarded this grade for all modules. For a grade of Pass with Distinction on the whole course, the student must have been awarded this grade on at least 15 credits of the course's 30 credits and a grade of Pass on the remaining credits.

## Entry requirements

General requirements and studies equivalent of the courses History 1b or 1a1+1a2 and Social Studies 1b or 1a1+1a2 from Swedish Upper Secondary School.

- The course is offered at the Centre for Languages and Literature, Lund University.
- This course replaces LIVA11 + LIVA21 and LIVA12 + LIVA22. It also replaces LIVA01 and overlaps with the first 30 credits in LIVA04.
