Details of approval

The syllabus was approved by The pro-dean for First-Cycle Studies at the Faculties of Humanities and Theology on 2019-05-27 and was last revised on 2022-05-11. The revised syllabus applies from 2022-05-11, autumn semester 2022.

General Information

The course is a compulsory component of the Bachelor of Arts programme in Fashion Studies. It can be included in a first or second cycle degree.

Language of instruction: Swedish

Some components may be taught in other Scandinavian languages and English.

Learning outcomes

On completion of the course, the students shall be able to

Knowledge and understanding

- provide a general account of the development of the field of fashion studies in the Swedish higher education system as well as of some key concepts, issues and theoretical perspectives in fashion studies
- provide a general account of the broad changes to the fashion of European women and men over time from approximately 1350 until the 1780s in relation to other aesthetic expressions and in a history of style context
- provide a basic account of fashion ideas connected to social and conceptual

changes

- provide a general account of the role and function of fashion in the transition from a society of estates to a modern consumer and class society
- provide a general account of the theories about the origin of fashion

Competence and skills

- in speech and in writing, based on selected issues, reflect on the fashion consumption of individuals in relation to a global fashion production
- in speech and in writing, present a chosen object based on the different perspectives and issues covered in the course

Judgement and approach

- at an independent level, approach and discuss a future identity as a fashion expert
- in speech and in writing, reflect on fashion in relation to power, gender and class from a historical perspective.

Course content

The course is included in the first semester of the Bachelor's programme. The course provides an introduction to the contents and design of the programme and demonstrates the breadth of fashion studies as a multidisciplinary field based on historical and cultural perspectives. The course gives a first general presentation of some key concepts, issues and themes that will be studied in depth during the programme. It introduces some basic forms of academic teaching and study included in the programme and initiates a conversation about the identity and areas of expertise of a fashion expert.

The course also covers fashion's relationship to clothes and to concepts of gender differences, estates and classes. Students in the course discuss the importance of clothes as a social marker and symbol as well as the role of fashion in the transition from a society of estates to a modern consumer and class society. Fashion is studied in relation to other aesthetic cultural manifestations and is broadly placed in a context of style history and history of ideas from approximately 1350 until the 1780s. Issues relating to the origin of fashion are discussed.

In addition, the course gives a short presentation of the development and establishment of fashion studies in the Swedish higher education system.

Course design

Teaching consists of lectures, group work and approximately one study visit and two to three seminars. The seminars are compulsory. During the course, the students are required to complete two individual written assignments that also are presented orally.

Absence from compulsory seminars must be compensated for by written assignments. The oral presentations are complemented by an oral catch-up exam.

Assessment

The assessment is based on one home exam.

Three opportunities for examination are offered in conjunction with the course: A first examination and two re-examinations. Within a year after the end of the course at least two additional examination sessions on the same course content are offered. Thereafter, the student is offered further examination opportunities but in accordance with the current course syllabus.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.
