# Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2018-06-13 and was last revised on 2020-09-22. The revised syllabus applies from 2020-09-22, autumn semester 2021.

# **General Information**

Compulsory course in Bachelor's Programme in Music: Vocal Studies, Piano, Guitar, Recorder, Harpsichord, Symphony Orchestra Instruments, first cycle 180 credits, and Bachelor's Programme in Church Music first cycle 180 credits.

Language of instruction: Swedish

### Learning outcomes

The aim of the course is to enable students to acquire the following knowledge and skills on completion of the course.

### Knowledge and understanding

The student shall on completion of the course

- show good direction towards a basic ability to perceive, structure, notate/describe and memorize sounding processes,
- show good direction towards a basic ability to aurally perceive different kinds of musical contexts,
- show good direction towards a basic ability to accurately reproduce rhythmic structures, and

• show good direction towards a basic ability to use development methods for aural skills.

#### Competence and skills

The student shall on completion of the course

- show good direction towards a basic ability to use aural skills and inner hearing in the personal music-making,
- show good direction towards a basic ability to analyse and describe different musical contexts and structures and also
- show good direction towards a basic ability to independently solve aurally related assignments or problems.

#### Judgement and approach

The student shall on completion of the course

• show good direction towards a basic ability to identify own needs of skill development.

### Course content

The course mainly consists of listening exercises and exercises in reproducing rhythmic and tonal processes by notating and/or singing/playing.

## Course design

The course is carried out in the form of group lessons and individual work (practicing, preparations).

### Assessment

Examination of the course is arranged through continuous assessment and final tests. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

### Grades

Marking scale: Fail, Pass, Pass with distinction.

The course grade relates to the fulfillment of the learning outcomes of the course.
