Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2017-11-29 to be valid from 2017-11-29, autumn semester 2017.

General Information

Compulsory course in Master's Programme in Music: Symphony Orchestra Instruments, Piano, Vocal Studies, Guitar, Recorder, Harpsichord, second cycle 120 credits.

Language of instruction: Swedish and English

Main field of studies

Music

Learning outcomes

To independently and on a high level be able to act in musical life, the student shall on completion of the course have acquired the knowledge, skills and values formulated below.

Knowledge and understanding

The student shall on completion of the course

- show excellent instrumental/vocal craftsmanship,
- have developed a broad knowledge within the main field of study,
- show a considerably deepened knowledge and understanding of part or parts of the main field of study, including insight in current research and development work, and
- have a deepened knowledge of artistic processes in general and own working methods in particular.

Competence and skills

The student shall on completion of the course

- show the ability to critically reflect on the personal artistic approach, and that of others, within a wider artistic context,
- have the ability to independently, and together with others, identify, formulate and solve artistic problems and problems regarding interpretation,
- show the ability to create and realize own as well as shared artistic ideas with a developed personal expression and also
- show excellent ability for musical interplay in different constellations and ensembles.

Judgement and approach

The student shall on completion of the course

- show the ability to, within the main field of study, make assessments considering relevant artistic, social and ethical aspects and also
- show the ability to identify the personal need for further knowledge and take responsibility for the personal knowledge development,

Course content

The course content is determined by the preconditions that follow repertoire and ensemble type and are specific to the instrument. The course mainly consists of work from the chamber music repertoire. In the courses Chamber Music 1- 4 the repertoire should comprehensively highlight the different epochs of music history, including contemporary music.

Course design

The course is carried out in the form of individual lessons, group lessons, seminars, guest lectures, workshops/master classes and individual work (practicing, preparations). Attendance: A minimum of 80%.

Assessment

Examination of the course is arranged through continuous assessment, concerts or tests. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Grades

Marking scale: Fail, Pass.

Entry requirements

In addition to general entry requirements for higher education at second cycle level the following specific entry requirements are applied:

Degree of Bachelor in Music 180 credits or the equivalent as well as passed selection based entrance examination for Master's Programme in Music.
