### **Details of approval**

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2017-11-29 and was last revised on 2022-10-12. The revised syllabus applies from 2023-01-01, spring semester 2022.

### **Judgement and approach**

The student shall on completion of the course

### **Course content**

The content of the course is based on the individual student's needs. Together with the faculty management the student makes an individual study plan in which is placed strong emphasis on the student's needs and vision for musical development and direction. The course assumes approved result of earlier course MUUF94.

### **Course design**

The course can be carried out in the form of individual lessons, group lessons, seminars, workshops/master classes and individual work (practicing, preparations).

### **Assessment**

Examination of the course is arranged through continuous assessment and tests/exams. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.
