### Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2017-11-29 to be valid from 2017-11-29, autumn semester 2017.

### General Information

Compulsory course in Bachelor's Programme in Music: Symphony Orchestra Instruments, Vocal Studies, Recorder, first cycle 180 credits.

*Language of instruction:* Swedish and English

### Learning outcomes

The aim of the course is to enable students to acquire the following knowledge and skills on completion of the course.

### Knowledge and understanding

The student shall on completion of the course

- show well developed craftsmanship and
- when playing/singing show a well developed understanding of the style and expression of the current repertoire.

### **Competence and skills**

The student shall on completion of the course

- show the ability to formulate and independently study and carry out artistic assignments based on good knowledge of performance practice,
- show the ability to critically reflect on the own artistic approach in a wider artistic context and also
- show a developed ability on a high level for musical interplay in different constellations and ensembles.

### **Judgement and approach**

The student shall on completion of the course

- show good ability to co-operate with other artists.

### **Course content**

The course mainly consists of relevant literature for the specific instrument. In the courses Study and Interpretation 1- 6 the repertoire should comprehensively highlight the different epochs of music history including contemporary music. The course assumes approved result of earlier course MUUL74.

### **Course design**

The course is carried out in the form of individual lessons, group lessons, seminars, guest lectures, workshops/master classes and individual work (practicing, preparations).

### **Assessment**

Examination of the course is arranged through continuous assessment, concerts or tests. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.
