### Details of approval

The syllabus was approved by Education Committee of the Performane and Church Music Department on 2017-11-29 to be valid from 2017-11-29, autumn semester 2017.

### General Information

Compulsory course in Master's Programme in Music: Composition, second cycle 120 credits.

*Language of instruction:* Swedish and English

*Main field of studies*

Music

### Learning outcomes

To independently and on a high level be able to act in musical life, the student shall on completion of the course have acquired the knowledge, skills and values formulated below.

### Knowledge and understanding

The student shall on completion of the course

- have excellent instrumentation skills and

- have excellent knowledge of the aesthetic orientations and values of the instrumentation in contemporary western art music.

### **Competence and skills**

The student shall on completion of the course

- show the ability to critically reflect on the personal artistic approach, and that of others, within a wider artistic context, and
- independently identify, formulate and solve artistic problems and problems regarding interpretation.

### **Judgement and approach**

The student shall on completion of the course

- show the ability to, within the main field of study, make assessments considering relevant artistic, social and ethical aspects and also
- show the ability to identify the personal need for further knowledge and take responsibility for the personal knowledge development,

### **Course content**

The course can contain instrumentation analysis, shorter exercises in relevant techniques as well as advanced instrument performance. The course assumes approved result of earlier course MUUT32.

### **Course design**

The course is carried out in the form of group lessons and individual work (exercises, preparations).

### **Assessment**

Examination of the course is arranged through continuous assessment and tests. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

## **Entry requirements**

In addition to general entry requirements for higher education at second cycle level the following specific entry requirements are applied:

Degree of Bachelor in Music 180 credits or the equivalent as well as passed selection based entrance examination for Master's Programme in Music.
