The syllabus was approved by Education Committee of the Performane and Church Music Department on 2020-03-30 to be valid from 2020-04-01, autumn semester 2020.

General Information

Compulsory course in Master's Programme in Music: Composition - Scoring for Film and Media, second cycle 120 credits.

Language of instruction: Swedish and English

Main field of studies

Music

Learning outcomes

To independently and on a high level be able to act in musical life, the student shall on completion of the course have acquired the knowledge, skills and values formulated below.

Knowledge and understanding

The student shall on completion of the course

- show good direction towards excellent knowledge of the musical craftsmanship through awareness of the importance of different parameters,
- show good direction towards excellent knowledge of different composition techniques from a historical perspective and
- show good direction towards excellent knowledge of classical and contemporary repertoire and relevant literature.
- show good direction towards considerably deepened knowledge and understanding of part or parts of the main field of study, including insight in current research and development work, and
- show good direction towards deepened knowledge of artistic processes in general and own working methods in particular.

Competence and skills

The student shall on completion of the course

- show good direction towards the ability to critically reflect on the personal artistic approach, and that of others, within a wider artistic context,
- show good direction towards the ability to independently identify, formulate and solve artistic problems and problems regarding interpretation,
- show good direction towards the ability to create and realize own artistic ideas with a developed personal expression and
- show good direction towards the ability to plan and with adequate methods carry out qualified artistic assignments within given time frames.

Judgement and approach

The student shall on completion of the course

- show good direction towards the ability to, within the main field of study, make assessments considering relevant artistic, social and ethical aspects and also
- show good direction towards the ability to identify the personal need for further knowledge and take responsibility for the personal knowledge development.

Course content

The course contains criticism/assessment/analysis and conversations, held at a high level, concerning the students' own works; overview/analysis of works representing different ensemble and work types within the scope of contemporary stylistic orientations; meetings with professionally active composers; conversations on aesthetics. The course assumes approved result of earlier course MUUT15.

Course design

The course is carried out in the form of individual lessons, seminars, guest lectures, workshops/master classes and individual work (analysis, composition and presentation assignments, exercises, transcriptions and other preparations).

Assessment

Examination of the course is arranged through continuous assessment and tests/exams. Examination rules, such as examination requirements and mark limits, shall be communicated to the student at the beginning of the course.

Re-examination of the course shall be offered in close connection to the regular examination.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Grades

Marking scale: Fail, Pass, Pass with distinction.

The course grade relates to the fulfillment of the learning outcomes of the course.

Fail means insufficient fulfillment of the course learning outcomes.

Pass means sufficient fulfillment of the course learning outcomes.

Pass with distinction means good and in-depth fulfillment of the course learning outcomes.

The course grading is done through the qualitative weighing of the fulfillment of the individual course learning outcomes.

Entry requirements

In addition to general entry requirements for higher education at second cycle level the following specific entry requirements are applied:

Degree of Bachelor in Music 180 credits or the equivalent as well as passed selection based entrance examination for Master's Programme in Music.
