### Details of approval

The syllabus is an old version, approved by The Board of the Department of Economics on 2011-06-07 and was last revised on 2019-11-05. . The revised syllabus applied from 2019-11-05. , spring semester 2020.

### General Information

This is a single subject intermediate course in economics belonging to the specialisation in 'Public Economics, and Health and Labour Economics'. The course is optional within a number of undergraduate programmes at Lund University.

### Learning outcomes

#### Knowledge and understanding

Students shall have demonstrated a good knowledge and understanding of key theories in labour economics and their implications.

#### Competence and skills

Students shall have the ability to independently:

- describe and evaluate the functioning of labour markets using adequate theoretical and empirical concepts and tools,
- apply the tools of labour economics to analyse policy and other issues related to

the determination of labour supply, labour demand, wages, employment and unemployment as well as issues related to labour market outcomes for different demographic groups,

- communicate and explain their analyses and conclusions clearly and concisely in both oral and written form

### **Judgement and approach**

Students shall be able to critically evaluate the arguments for and against different public interventions in labour markets.

### **Course content**

The course aims to introduce students to key theories in labour economics and to how they can be applied in the analysis of labour market institutions, the functioning of labour markets, and current policy issues. The course looks at theories and empirical studies of how labour markets function and how they are affected by public interventions of various kinds. It covers theories of labour supply and labour demand, human capital theory, theories of wage determination and discrimination as well as theories of unemployment and labour market policies. The different theories are related to empirical data and empirical studies concerning, mainly, the Swedish labour market. Special attention is given to immigrant and gender issues.

### **Course design**

1. Teaching: The course is based primarily on lectures but supplemented by two mandatory workshops devoted to current labour market and labour market policy issues.

### **Assessment**

1. Examination: The main part of the examination consists of a written, individual examination covering the textbook, other assigned reading material and the contents of the lectures. Written exams take place at the end of the course. The second part demands that the student plays an active part in the workshops and completes a specific workshop assignment. Participation in the workshops must take place in the same term as the written examination.

2. Limitations on the number of examination opportunities: –

The University views plagiarism very seriously, and will take disciplinary action against students for any kind of attempted malpractice in connection with examinations and assessments. Plagiarism is considered to be a very serious academic offence. The penalty that may be imposed for this, and other unfair practices in examinations or assessments, includes suspension from the University for a specified period.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.
