Details of approval

The syllabus was approved by Committee for Single Subject Courses at the Department of Psychology on 2020-04-08 and was last revised on 2021-12-01. The revised syllabus applies from 2023-03-15, autumn semester 2023.

General Information

The course is offered as a first cycle freestanding course and may be included in a Bachelor's degree specialising in psychology or in a degree programme in accordance with the programme syllabus.

Learning outcomes

On completion of the course, the student shall demonstrate

Knowledge and understanding

- understanding of what is represented by social psychology and how it is related to adjacent fields
- knowledge about both classical studies in social psychology and the phenomena addressed by present-day research
- knowledge about group processes and individual behaviour in groups
- knowledge about attraction and relations between individuals
- knowledge about attitudes and the interplay between attitudes, attitudinal change and behaviour
- knowledge about different ways of actively influencing people's views (social

persuasion)

- understanding of the elements affecting our view of ourselves and others and how we establish reasons for our own and others' behaviour
- knowledge about stereotyping and prejudice and how to reduce prejudice and discrimination
- knowledge about the background to aggression and altruism
- knowledge about the most common methods of data collection in social psychology research, and the advantages and drawbacks of different methods
- knowledge about the different types of tests used in social psychology (such as attitude measurement using self-assessment forms)
- knowledge of how social psychological theory can be applied in society

Competence and skills

- the ability to describe the applicability of theories and knowledge of social psychology in society
- the ability to conduct simple investigations in social psychology by means of questionnaires
- the ability to provide organisations with information about the impact of conscious and unconscious prejudice on selection and recruitment
- the ability to propose solutions to problems such as discrimination in the workplace
- the ability to communicate social psychological knowledge to different target groups

Judgement and approach

- the ability to critically assess information concerning social psychology
- the ability to search for and assess research information concerning social psychology

Course content

The course consists of four modules.

Module 1. Introduction to Social Psychology (7.5 credits)

The module provides students with an introduction to theories and concepts of social psychology. It deals with both classical studies and modern perspectives.

Module 2. Stereotyping and Prejudice (7.5 credits)

The module provides students with an introduction to the origins of prejudice and methods to address prejudice.

Module 3. Applied social psychology (7.5 credits)

The module focuses on how social psychological theory and research can be used to develop measures to handle social problems.

Module 4. Project (7.5 credits)

The module consists of a supervised empirical study of an issue in social psychology.

Course design

The teaching consists of lectures, laboratory exercises/demonstrations, seminars and supervision. All components of teaching except the lectures are based on active participation and therefore compulsory. Unless there are valid reasons to the contrary, compulsory participation is required. Students who have been unable to participate due to circumstances such as accidents or sudden illness will be offered the opportunity to compensate for or re-take the compulsory components. This also applies to students who have been absent because of duties as an elected student representative.

Assessment

Examination takes place in the form of a written examination, individual thesis, written assignments and a final empirical project work that is presented both orally and in writing. Three opportunities for examination are offered in conjunction with the course: a first examination, a re-sit close to the first examination and a second re-sit in the same year. Within a year after a major change to the course or its cancellation, at least two further opportunities for assessment are offered on the same course content. After this, further re-examination opportunities are offered but in accordance with the current course syllabus.

The examiner, in consultation with Disability Support Services, may deviate from the regular form of examination in order to provide a permanently disabled student with a form of examination equivalent to that of a student without a disability.

Subcourses that are part of this course can be found in an appendix at the end of this document.

Grades

Marking scale: Fail, E, D, C, B, A.

The highest grade is A and the lowest passing grade is E. The grade for a non-passing result is Fail. The student's performance is assessed with reference to the learning outcomes of the course. For the grade of E the student must show acceptable results.

For the grade of D the student must show satisfactory results. For the grade of C the student must show good results. For the grade of B the student must show very good results. For the grade of A the student must show excellent results. For the grade of Fail, the student will have shown unacceptable results.

The grades awarded on the invigilated written exams on modules 1, 2 and 3 are A, B, C, D, E or Fail. As grade for the project work on module 4 (Essay project), one of the terms is used Pass or Fail. For the grade of Pass, the student must show acceptable results. For the grade of Fail, the student will have shown unacceptable results.

For final course grade, a joining is made by the module grades from module 1, 2 and 3. The final grade on the course is based on a weighting of the grades on the modules in which an average is calculated for the modules with differentiated grades (in which A=5, B=4, C=3, D=2 and E=1). For a grade of Pass (at least E) on the whole course, the student must have been awarded a grade of E on all assessed components and completed all compulsory components.

At the start of the course, students are informed about the learning outcomes stated

in the syllabus and about the grading scale and how it is applied in the course.
