Kursens mål

A passing grade on the course will be awarded to students who:

Knowledge and understanding

- Show knowledge and understanding about entrepreneurship in general, and in the specific area of the entrepreneurial business project
- Show methodological knowledge in entrepreneurship in an applied format.

Skills and abilities

• Show an ability to judge and handle complex issues and situations in relation to new venture creation

- Show an ability to independently develop an entrepreneurial idea, and realize this idea in form of a venture within a very limited timeframe
- Show skills and abilities to communicate and market concepts, ideas, products and/or services to a relevant audience.

Judgement and approach

- Are able to evaluate the overall and long-term sustainability of the new venture in terms of financial, social, environmental and financial sustainability of the new venture idea.
- Show an ability to take personal responsibility for continuous competence development

Kursens innehåll

This is a highly practice oriented course with the end goal of developing the students functional skills in entrepreneurship. This is done through an experiential learning method, where our students need to engage in and going through all the steps of starting a new venture and (in appropriate cases) actually doing so. The process of business creation is supervised by the teaching team and a large team of business mentors.

Kursens genomförande

Teaching methods will vary, but primarily consist of lectures, workshops and case discussions. The students' business projects will be in focus when theories are discussed and applied.

Examination primarily consists of a business plan, trade show presentation and learning journals. The relation between examination and learning outcomes is explained below:

The business plan

- Enables the students to show degree of methodological knowledge in entrepreneurship in an applied format.
- Enables students to primarily demonstrate ability to integrate knowledge, analyze, judge and handle complex situations and issues with limited information.
- It also enables them to demonstrate an ability to independently identify and formulate their own business idea and plan how to execute this task appropriately. They will be able to demonstrate skills and abilities to communicate and market concepts, ideas, products and/or services in both written and oral formats in the business plan assignment.
- Moreover, the business plan enables the student to evaluate the overall and long term sustainability of the new venture in terms of financial, social, environmental and financial sustainability of the new venture idea.

The Trade show

• The tradeshow enables the students to demonstrate ability to independently identify and formulate their own business idea and plan how to execute this task appropriately. They will be able to demonstrate skills and abilities to communicate

- and market concepts, ideas, products and/or services visually and orally during the tradeshow.
- Show skills and abilities to communicate and market concepts, ideas, products and/or services to a relevant audience.
- By planning and evaluate the tradeshow the students can show an ability to take personal responsibility for continuous competence development.

The learning journal

- Enables the student to show knowledge and understanding about entrepreneurship in general, and in the specific area of the business project.
- Enables the students to show ability to judge and handle complex issues and situations in relation to new venture creation.
- Enables the student to show ability to independently develop an entrepreneurial idea, and realize this idea in form of a venture within a very limited timeframe.
- Enables the student to show an ability to take personal responsibility for continuous competence development.

The students will be examined both individually and in groups.
